MIN: 1/12/03/2021: PRELIMINARIES

Thereafter the NGCDFC secretary Mrs.Serah Mbugua opened the meeting with a word of devotion from the book of John 19:16-17. She also took members through the agenda of the days meeting as highlighted above.

MIN: 2/12/03/2021: READING AND CONFIRMATION OF PREVIOUS MEETING MINUTES

The minutes of the last NGCDFC Meeting held on Tuesday 9th February 2021 were read out by the NGCDFC Secretary and were confirmed as true deliberations on the material day by being proposed by Mr. Tom Githire and seconded by Mrs.Judy Kimani.

MIN: 3/12/03/2021: MATTERS ARISNG

On Min: 5/09/02/2021: The fund Account Manager reported that the funds were transferred from main Account to Project Account and all the pending bills to the contractors have been paid so far.

MIN: 4/12/03/2021: REVIEW OF DRIVING COURSE GRADUATION

The bursary subcommittee chairman informed the members that out of 533 students who completed the driving course, Rocky driving School presented the following documents; 138

complete certificates and interims, 9 complete interims with no certificates and a number of 406 duplicated interims. He also said that a number of certificates had spelling mistakes that need to be rectified. In response the fund manager said that the graduates who did not receive their documents are been assisted at NGCDF office to acquire them. Despite the challenges, members appreciated the fact that the graduation ceremony was colourful and the impact of the NGCDF funds have been felt at the grassroots level through youth empowerment.

MIN: 5/12/03/2021: NGCDF SPORT TOURNMENT FINALS

The Male Youth representative informed members that the constituency knock outs is still ongoing and are being held on Saturdays because of other ongoing premier leagues taking place on Sundays. Members after deliberations agreed to hold the constituency finals on 18th April, 2021 at Githunguri stadium. In preparation of the day, members mandated the office to tender for supply of sports uniform for the (64teams) and full attire for the winning teams. Members also agreed that the coaches for the 16 qualifying teams will be awarded with track suits together with office staff.

MIN: 6/12/03/2021: PREQUALIFICATION OF CONTRACTORS/SUPPLIERS REPORT

The Clerk of works informed members that bidders were invited through open advert on 27th January 2021 as per requirements of Public Procurement and Assets disposal Act 2015. He thus took members through the Tender opening minutes done on 12th February 2021. He said that out of fourteen (14) tenders, three (3) were not tendered for namely:

- Prequalification for provision of conference and training services (Open)
- Prequalification for provision of internet services(Open)
- Pregualification for disposal of sanitary towels service(Y/PWDs)

He further said that a total of ninety two (92) bid documents were received and only only one (1) tender was rejected due to late delivery. The NGCDFC members after lengthy deliberation adopted the report by being proposed by Mrs.Judy Kimani and seconded by Mr.William Ngotho.

The clerk of works also took members through the tender evaluation report carried from 23rd February 2021 to 3rd March 2021. The rigous work of the committee was to check validity of the documents attached by using KRA AND NCA online platform and most of contractors failed

MIN: 7/12/03/2021: REALLOCATION OF PROJECT FUNDS FOR 2020/21 FY

Members were presented with a proposal for Ngewa Primary School for rehabilitation of school infrastructure which are in deplorable state and thus cannot await 2021/2022 FY allocation since it requires immediate attention.

Members discussed at length and unanimously agreed to reallocate funds allocated to Kihuririo Primary School in the financial year 2020/2021 amounting to Kshs, 6,100,000 since the school had earlier benefited with NGCDF funds in the financial year 2016/2017 and thus the classrooms are far much better and thus can await future allocation in order to carry out a complete face lift of the school as was the intended. The activity of the new proposed project will be as follows;

Members also approved payment of *Kshs*, *9,450*(Nine thousand four hundred and fifty only) to postal corporation of Kenya as annual rental fee for the year 2021.

Members approved transfer of project funds for Kiairia Primary school amounting to Kshs, 879,116(eight hundred seventy nine thousand one hundred and sixteen) from main Account to project account to facilitate payment of pending bill to the contractor.
