The secretary read the previous minutes which were confirmed as a true copy of what had been discussed in the previous meeting. The minutes were seconded by Kennedy Kiruki and Valentine Njoki.

MIN 003/21/04/2021 RESUBMISSION OF MURURIINI POLICE POST PROJECT

The F.A.M notified members that the above project to construct a 400 capacity social hall to completion ksh 5, 500, 000, construction of a 3 door pit latrine toilet block and urinal ksh 550,000, fencing of the 0.05 hectares compound with concrete posts and wire mesh to completion ksh 600,000 was rejected and needed to be reallocated to another place outside the police post.

Members resolved that since the assistant chief Mururiini has a big compound to accommodate a similar project the project be done there. Thus it would be resubmitted to **Mururiini Assistant Chiefs office worth ksh 6,650,000.**

MIN 004/21/04/2021 RE-ALLOCATION OF MUKUI PRIMARY SCHOOL PROJECT & SAGANA MUSLIM PRIMARY SCHOOL PROJECT

The Fund Account Manger notified the members that an error had occurred during the submission of Mukui Secondary School and was submitted as Mukui Primary School. This therefore needed to be reallocated to Mukui Secondary School to fit the intended need i.e to construct a tiled classroom to completion at Kshs 1,200,000.

In addition to that, she also briefed the Members on re-allocating the Sagana Muslim Project meant to drill borehole and solarizing it at a cost of ksh 3,700,000 to Sagana Assistant Chiefs Office. This would enable water to flow to the primary school with gravity and also serve the Assistant Chiefs office, D.O s and youth's office which are located in one compound. The members unanimously approved the reallocation of the two projects
