MIN: CDFC.009/07/2021. Chairman's Opening Remarks.

The meeting commenced at 10.00am with the chairman welcoming members and requesting Mr. Abdi Mohamed to pray. The chair then requested the secretary to read the previous minutes.

MIN: CDFC.010/07/2021. Reading and confirmation of the previous minutes

The secretary read the minutes of the previous meeting and they were confirmed to be a true deliberation of the day having been proposed by Hassan Daud and seconded by Ahmed Hassan.

MIN: CDFC. 011/07/2021. Re-allocation of projects

Following the Gazzetment of the Bodhai sub-county, the chairman informed members of the urgent need to construct administration block to enable operationalization of the sub-county activities to help enhance the security in the area. The committee after a long deliberation, resolved that due to delay in the enrolment of students in Ijara Technical Training Institute, Kshs. 7,000,000 be re-allocated towards construction of the administration offices for Bodhai Subcounty headquarters. The allocation to Ijara TTI for the purchase of 51 seater bus to be done in the next financial year. The committee also resolved to reallocate Kshs. 5,000,000 for County Council Secondary School meant for Construction of 60 student capacity laboratory (4,000,000) and purchase of lab equipment (1,000,000) to completion be reallocated to Kotile Girls Secondary School towards construction of 60 student capacity laboratory to completion. The laboratory was an additional lab to county secondary school while Kotile has no single laboratory. If need be, the same to be constructed in the next financial year.
